## Gift Aid relief

The Society has now registered with the Charity Commission a new charitable fund, so that donations will attract Gift Aid relief. We therefore need all donors to redirect their giving to the SOF Charitable Trust (SOFCT), and to complete the Gift Aid Declaration.

*See below how to do this.*

### SOFCT will fund three objectives:

- Capital improvements at the College
- Scholarships and bursaries to enable future and existing pupils to receive the benefit of education at the College, and
- Benevolence for those OFs who have fallen on hard times, an area where our Trustees have been called on twice in 2014.

### Existing Standing Order donors:
